## 11. Staff Reports

### a) CEO's Report

- i. **Update RE: Installation of Bulletin Boards:** B. Noel contacted A&E Ceramics as directed and learned that A&E Ceramics does not do installation of anything other than ceramic tile. A&E Ceramic did recommend that the installation of the bulletin boards be done using a concrete drill bit; B. Noel has experience working with ceramics and glass and has indicated that he does not foresee any problem with the installation. B. Brown of Bel-CON made the same remarks in his note to me last month when I asked him about possible problems with an installation of bulletin boards on the tile wall in the Foyer.
- ii. **Lighting Report Update:** B. Noel reported that Bruce Burnette had contacted him and that he was working on a final version of the lighting evaluation for his report.
- iii. **Plaque Design:** Please see the attached DRAFT "Plaque Design" document. After some discussion this item will be referred to Councillor T. Christopher. Further discussion about the plaque will take place at the Property Committee.
- iv. **Tender for Signage:** Please see the DRAFT "Tender for Signage" document. After some discussion this item was referred to the Property Committee for further action.
- v. **Update on AODA Training for Library Staff:** SOLS has agreed to conduct an "Accessibility for Ontarian with Disabilities Act (AODA) training session for the Library on Friday 13 November 2009. The CEO recommends that the Library be closed for the day in order for SOLS to conduct the training for the entire complement of Library Staff. This training session will satisfy our compliancy requirements under the new AODA legislation.
